## NEW YORK YOUNG UN 2025 CONF. B

New York Young UN - Conference B The Ambassador of the Future is the conference dedicated to high school students which will take place in New York City

- **5000 Students**
- **8 March - 16 March 2025**
- **High school**
- **New York**

The New York Young UN Ambassador of the Future training program is a conference that will take place in New York City from March 8 to March 16, 2025 (9 Days – Conference B, Session I) and is the largest diplomatic simulation of the UN model in the World with the participation of 5000 high school students from over 100 countries and 6 continents.

The students who participate in the project will study and discuss the issues of the international political agenda by wearing the role of ambassadors and diplomats. In carrying out this role, the delegates carry out the typical activities of diplomacy: they give speeches, prepare draft resolutions, negotiate with allies and adversaries, resolve conflicts and learn to move within the Committees by adopting the rules of procedure of the United Nations (UN).

The UN Ambassador of the Future model provides a real training and educational experience for the students, they learn to cultivate excellent communication and decision-making skills by exploiting the power of compromise, consensus and international cooperation for effective negotiations, through the representation of a State assigned in a specific insertion commission.

The Conference offers participants the opportunity to truly embrace the mindset of a diplomat in a unique setting: the hall of the United Nations General Assembly, where the world's most important leaders meet, in New York, United States.

N.B: The use of United Nations space is always subjected to the availability and approval of the UN. The United Nations reserves its own priorities that understandably may take precedence over ours. The only requirement for access to the program (Delegate Program) is knowledge of the English language.

## DELEGATE PROGRAM

From 03/08/2025 to 03/16/2025 Conference B (9 days in New York City)

NEW YORK YOUNG UN 2025 TRAINING PROGRAM-Conference B (reserved for high school students)

This program is organized by the WSC Global Leaders Fzco Agency as regards training and study travel services.

All secondary school students regularly enrolled in high schools, technical and professional institutes aged between 14 and 19 can apply to participate. The selected students will take part in the Delegate Program (12-13-14-15 March 2025) "The Ambassador of the Future" training program - an overall project lasting 8 nights and 9 days.

Eligible participants will obtain accreditation to the Conference, a title suitable for representing a country or a non-governmental organization (NGO) within a specific UN commission during the diplomatic simulation.

Those registered are required to participate in the modules of the training course (consisting of UN project experts), in the activities related to the simulation, as for the regulations of the organizing body, and to draw up their own Position Paper within the deadlines established by the Wsc Agency Global Leaders Fzco. The training course will be managed by WSC Global Leaders Fzco via the digital platform Zoom and will begin in early December 2024.

In the event of negligent behaviour resulting from the Delegate's total or partial failure to participate in the activities indicated above, the management of the Wsc Global Leaders Fzco Agency reserves the right not to issue the certificate of participation in the training program. The preparation course for the Program includes a commitment of 36 hours for online frontal teaching, 20 hours for research and individual study, 30 hours for participation in the project, 14 hours for pre-simulations, conferences and meetings, for a sum total hours of 100.

Without a scholarship, the certification must be attached to the online application form.

The interview will take place electronically via the SKYPE video call program

The student who has not reached the age of majority will have to take the interview in the presence of a parent or first or second degree relative.

## PARTECIPATION

Only those who are admitted to the training program through an interview in English and will have access to the training course to prepare for the diplomatic simulation will be able to join the Delegate Program. The project will be held in New York from 8 March to 16 March 2025. If a minor, the student will have to take the interview in the presence of a parent or first or second degree relative.

Those entitled to participate in the Delegate Program must complete the form of the General Conditions of the Training and Study Travel Services, carried out by the WSC Global Leaders Fzco agency (which will be sent via email to all eligible candidates) to be forwarded to the email address

## CODE OF CONDUCT

Art. 1. Wsc Global Leaders Fzco is an Agency that recognizes the value of cultural diversity and aims to bring high school students closer to a study model based on knowledge and comparison.

Art. 2. Students who join our initiatives are required to view and accept the internal regulations and to conform to the style and model of behaviour of the Agency. They will have to dress appropriately for the circumstances and places where the activities will take place and always show respect for the people they will meet during the training courses directed by the WSC Global Leaders Fzco Agency, as well as the international students and professors who will take part in the simulation.

Art. 3. Absences during training courses must always be justified. In the phase following the selection, the student's conduct will be subject to evaluation by the examining commission, any conduct considered inappropriate may be sanctioned with measures ranging from reprimand, to admonition, up to, in the most serious cases, expulsion from the Plan.

Art. 4. No absence is permitted during the simulation work, except for health reasons. For the entire duration of the stay at the New York City Conference, the student is not allowed to leave the group without specific authorization from his/her Faculty advisor or the tutor of both the lead organization and the reference partner agency. Any conduct contrary to what is described above may be sanctioned with measures ranging from a warning to a warning, up to, in the most serious cases, expulsion from the project and early return from New York City.

Art. 5. Sanctions are imposed unanimously by the Board of Directors of the Agency whose judgment is unquestionable. In cases of expulsion during the Training Course, the student is subject to a penalty. In cases of expulsion and early return from New York City, any additional costs will be paid entirely by the enrolled student's family.

### 1)How to enroll in WSC programs?

Registration for the WSC Global Leaders Fzco "The Ambassador of the Future" programs takes place via an Application Form request to be sent to the email address [selections@appform.ae](mailto:selections@appform.ae) or by filling out the App Form directly on the website: [appform@modelun.ae](mailto:appform@modelun.ae)

Once the electronic registration request has been received, an interview with the international department will be scheduled via email, which is essential for obtaining eligibility for the training programs.

WSC Global Leaders Fzco will communicate the outcome of the interview within 48 hours via email address [selections@modelun.ae](mailto:selections@modelun.ae)

In case of suitability and possible participation by the student, WSC Global Leaders Fzco will send by email the documentation to complete the participation in the Annual Programs (WSC Enrollment Fee) and the General Conditions of the Delegate for the use of the services linked to the selected training program from the same student

- **General conditions of the Delegate (acceptance of the services of the selected program)**

## **2)What does the payment of the registration fee for the Annual Programs (WSC ENROLLMENT FEE)?**

With the payment of the WSC Enrolment Fee, the student will in effect be enrolled for a whole year in all the programs developed by WSC Global Leaders Fzco, sharing the values and mission of the Agency. You will therefore have the right to participate in all national and international events and seminars organized by WSC Italia Global Leaders Fzco without completing further suitability interviews. You will be eligible to participate in all Programs during a one-year period and will be able to renew your membership from year to year or within 12 months it will automatically be canceled for the year

## **3) When is it possible to have the interview?**

It is possible to take the interview when enrolment in the program is in "Open Registration" mode which can be found in the section of the training project selected by the student.

Interviews are carried out by the international department via Skype from 3pm to 8pm

It is essential to have a Skype account and it is possible to have the interview via a smartphone, tablet or desktop/laptop PC with integrated camera and microphone for the correct conduct of the interview which will last 10 minutes.

## **4)What are the requirements?**

The fundamental requirement is basic knowledge of the English language, the remaining part of the interview will focus on the motivations that push the candidate to participate in an international program and questions and doubts about the project.

## **5) I am a high school student, can I enroll in the program?**

Yes, students who attend high schools and secondary schools must view the section of the programs dedicated to them: MODEL YOUNG UN – HIGH SCHOOLS

## **6) Is the interview free?**

The interview is free and does not imply any obligation to join the selected program, having a purely cognitive purpose.

There is no need to pay any fees or secretarial costs and once eligibility has been obtained, the student himself will decide whether to join the selected training program.

## **7)What are the costs?**

The costs of the program are reported within the training projects in the NOTICE section.

The Notice is the official document of the program where the costs, the payment in instalments, the services, the selection method, participation in Delegate or Guest Program mode and the code of conduct are reported.

## **8) Where will the training course take place?**

We have long abandoned the classrooms, thanks to new technologies the Delegate will be able to follow the training course in live mode via an application managed by WSC Global Leaders Fzco.

The course can be taken from home or abroad etc.

Simply connect a smartphone, tablet, laptop or desktop PC using a specific link that WSC will send to the student.



### 9) At the end of the simulation, will I receive a certificate?

On the last day of the simulation, all participants will receive a paper certificate of participation from WSC Global Leaders Fzco and the supporting bodies in partnership with the United Nations organisation.

In the following weeks, participants will receive a PDF certificate via email with the total number of hours of training and work carried out that can be used for the assignment of training credits, if provided for by the university/higher institute they belong to.
